
# CEI EL JARAMA BEHAVIOUR EXPECTATIONS



Registration for the camp implies that both participants and their legal representatives are aware of and accept the following rules:

## 1. Respect for other campers

**Disrespect, including physical or verbal aggression, intimidation, or harassment towards other participants, educators, or any other staff members of the CEI El Jarama camp (hereinafter, the Center) will not be tolerated.**



## 2. Phone calls

On predetermined schedules, **once a week**, families will be allowed to call their children. The Center does not guarantee the availability of children on other days or at times outside the designated camp schedule, nor can it ensure that they will receive more than two calls per day. **Call duration is also limited to 2-3 minutes to prevent overloading the phone lines.**



## 3. Mobile phones

The children will **not be allowed** to bring mobile phones to the Centre.



## 4. Family visits

Visits to camp or any of its excursion locations are **not allowed**, except for justified reasons that have been previously communicated to the Center by a parent or legal guardian.



## 5. Possession and consumption of drugs



Camp participants are **not allowed to bring or consume** tobacco, alcoholic beverages, or any other narcotic substances at the Center.

## 6. Facilities and equipment



Participants are required to **use the facilities, equipment, and materials—whether their own, their peers', or the Center's—responsibly**. Additionally, children are expected to participate responsibly in maintaining order and taking care of their rooms and belongings, as well as the materials used for activities.

## 7. Personal belongings



The theft or improper use of others' personal belongings is **considered a serious offense**. Additionally, the possession of sharp or pointed objects is prohibited at the camp.

## 8. Dining room



The menu the children are served at the dining room **will not be changed** except in the case of allergies or an intolerance to food, that has previously been notified in the enrolment form.

## 9. Use of spaces

Participants must remain in the areas **previously authorized** by the educators.



## 10. Schedules and activities

**Participants must take part in all scheduled activities**, except those they are unable to perform due to physical or mental reasons. They must also adhere to the Center's schedule, respecting rest periods.




## 11. Personal hygiene

Participants must comply with **common personal hygiene** standards and any specific rules established by CEI El Jarama.




## 12. Leaving the premises without permission

Leaving without permission from the enclosed area of the Centre will be **considered a serious offence**, as well as exceeding the limits established by the staff responsible for excursions outside the Centre.



## 13. Relations with educators, coordinators and managers



Participants will **accept the rules outlined above**, as well as any additional rules established for the development of the various activities. They will also accept any corrections that may need to be made.

## 14. Safety



The staff at CEI El Jarama will only hand over, the child to one of the individuals authorized as **parents/guardians** on the registration form.

The failure to comply with any of these rules or other general conduct guidelines by one or more participants will require the Center's management to take appropriate measures to restore harmony, including, if necessary, **the expulsion of the participant(s) from the CEI El Jarama camp**. In such cases, the child's parent(s)/legal representative(s) will be required to pick up the child within 5 hours, and no refund will be issued under any circumstances.
